Cleaning and Maintenance

Please be sure to include these materials in a regular cleaning and maintenance program. Remove all soil and spills as quickly as possible.

Most spills and recent soiling can be easily cleaned. Remove any excess spills with damp cloth. Clean with a mild liquid soap and warm water mixture (10% household dish soap / 90% water). Rinse with water and dry.

For heavy soiling use a one to one (1:1) solution of concentrated cleaners such as Formula 409® or Fantastik® and water. Rub gently and rinse with a water dampened cloth.

For more difficult stains, dampen a soft white cloth with a solution of household bleach and water (10% bleach / 90% water). Rub gently and rinse with a water dampened cloth to remove bleach concentration. Always rinse with clear water and dry. Never use full strength bleach to clean this material.

Certain clothing and accessory dyes (such as those used on denim jeans) may migrate onto the surface of the material and become visible on lighter colors. The phenomenon is increased by humidity and temperature and may be irreversible. Certain inks, including ballpoint inks, can create permanent stains.
